1. WELCOME AND YEAR IN REVIEW

President Rochelle Garfinkel presented her report (attached) and thanked the officers of Vancouver Section for their support and work over the past year.

The authorization being approved the following resolution was proposed by Audrey Lieberman and seconded by Rhea Lazar:

RESOLVED as an ordinary resolution that the solicitors for the Society, Norton Rose Fulbright Canada, LLP, be and are hereby authorized to electronically file the Bylaw Alteration Application giving effect to the amendments approved herein. RESOLUTION PASSED.

The President reaffirmed the information that tonight's Resolutions will not go into effect until after the registration of the Bylaws with the BC Registrar of Companies.
